Case Synopsis

On Saturday, 12/20/08, from 1300 to 2000 hours, unknown groups are planning a protest outside the Greek Consulate located at 69 East 79th Street. It is unknown if members of the Friends of Brad Will and/or Dennis Burke will be in attendance.

Background:

On 12/10/08, at approximately 0405 hours an unknown perpetrator wrote graffiti on the front wall of the consulate and threw a stone block at the front window causing damage to the window. The graffiti on the left side of the entrance door was an anarchy symbol represented with the letter "A" inside of the circle. Underneath the symbol was the word "murderers". On the right side of the entrance door was the word "burn!" and beneath that was "Alex was here". A witness observed the perpetrator flee on a bicycle headed eastbound on east 79th street, then southbound on park avenue.
