Case Synopsis

According to Press reports, Bradley Will, a documentary filmmaker and journalist affiliated with Indymedia, was shot and killed on October 27, 2006 in Oaxaca, Mexico while he was videotaping a protest by striking teachers. Demonstrations organized by the Friends of Brad Will were held outside the Mexican Consulate located at 39th Street and Madison Avenue in New York City on October 28 and October 30, 2006 to protest his murder by what demonstrators alleged were Mexican Government backed paramilitary forces. On October 26, 2007, two explosive devices were thrown at the Mexican Consulate in New York City and one of the devices detonated, smashing several windows but causing no injuries. The Friends of Brad Will are continuing to allege that the Mexican Government was responsible for his death.
