Plan of Action:

 - Ask CI Imam if he knows Mufti Qumar; if so attempt to get close to him.
- Conduct surveillance at **Masjid Madni** 24-04 89th Street East Elmhurst, NY 11369 where Qumar is the Imam.
- Ascertain phone number(s) for Mufti Qumar, subpoena phone records and submit them for analysis with numbers of SSP members already submitted.
- Re-Interview complainant/victim of altercation with Mufti Qumar's sons that occurred in October of 2006 from Bay Shore to see if there has been any contact between the two.
- Obtain Mufti Qumar's registered vehicle(s) and place Global Positioning System in order to better monitor his movements and possible associations.
- Check e-z pass information and track for possible state boarder crossings.
- Mail-cover conducted on Mufti Qumar's home address.
- Have Detective Siviglia direct CI 1297/05 to try and ascertain any further info on Qumar from SSP subjects
